# Who may join?

Any licensed health care professional may apply for membership. The internal credentialing process may take from thirty to ninety days. Once the membership application is reviewed and receives approval by the Medical Network One Credentialing Committee the application and supporting information are submitted to the health plans for enrollment. The enrollment timeline at the health plan varies from plan to plan. It may take up to six (6) months for health plan enrollment.
